
# Did you know that College Students are effectively gagged from organizing in Trenton on any legislation?

### Gag Rule REPEAL

#### New Jersey is the only state with this distinction.

In every state that the Student Public Interest Research Groups (Student PIRGs) has a chapter, New Jersey is the only state that prohibits legislative lobbying at the state level by any student organizations at public universities that are funded through waivable fees on the student term bill (a voluntary contribution.)



Student PIRGs complement and enhance students' academic experience, gaining valuable hands-on experience researching real world problems and policy solutions, educating others, and organizing activities to engage their fellow students. They find their voice and learn to advocate on issues they care about. But they have been barred from advocating on state issues and are losing out on the opportunity to experience the democratic process on the state-level.


### How does New Jersey effectively prevent the students from using their voices in the state legislature?

For the past 29 years, student leaders with NJPIRG Students have been legally barred from advocating on state legislation. If they organize to lobby or hire a legislative agent, they forgo about \$500,000 a year in funding that is raised through elective waivable fees on their tuition bills. This was a *highly effective* and *legal* way to keep them away from speaking out in support of or against any legislation. **How do we reverse this injustice?** 

We repeal the "Gag Rule" by passing bill <u>S4272</u> into law thereby restoring students' rights.

#### What does this waivable fee look like for students?

Below is a screenshot of what this waivable looks like on the tuition bill. Note that only students in the academic divisions that NJPIRG won in the 2022 student referendum gets assessed this fee and have this option to waive the fee. It is easy to read and makes it clear that they *can reduce their tuition bill balance* by checkmarking the box declining to contribute this fee. That is, this small contribution is voluntary and students are NOT REQUIRED to donate. Currently, about 35% of eligible students choose to waive the fee each semester.



### How can you help this bill?

We need constituents to call their state legislators to advocate for these college students who cannot advocate for themselves.

- Call your state legislators and tell them about the Gag Rule and its unjust silencing of our vouth.
- 2. Ask them to sign on as a bill co-sponsor.

Find your state legislators and call them today. Call and you'll likely speak to their district legislative staffer, a young person who may not know anything about this issue or bill. Ask them "Will Assemblyman/woman or Senator sign as A5670/S4272 bill co-sponsor?"
